Bookings and Payments

We can take bookings in a number of ways - online through our website, over the phone or by submitting a booking form electronically or in hard copy.

Classes or workshops starting within 3 weeks of booking must be paid in full. If starting further into the future you have the option to pay a deposit of £25 to secure your place, with the balance to be paid 3 weeks before the start date. Please contact us to pay this way.

Payment can be made online, by cheque (made payable to Birchwood Art Studio Ltd.), online banking or in person by card or cash. We cannot take payments over the phone but can send a secure payment link to a smartphone.

Cancellations & Refunds

We hope we don't have to cancel classes or workshops very often but there may be occasions when cancellation is unavoidable and refunds are required. We reserve the right to cancel courses and all courses are subject to a minimum number of participants.

Our refund policy is:

• To always offer a full refund if we have to cancel a class – we may also offer an alternative date or event but it's entirely up to the customer as to which they prefer

• We can't refund customers for classes they can't/don't attend once they've booked a place, but where possible we will offer them the same class on an alternative date

 Vouchers can't be exchanged for cash but have no expiry date and can be used for classes, Lost in Art sessions. Paint & Wine, workshops or in our shop

 Unless marked as non-returnable, shop items can be returned within 30 days providing there is proof or purchase, they are in their original packaging and are unused.

If we can, we will offer you a substitute date or the chance to catch up at an open studio session but this is subject to availability and at our discretion.

Conduct

It is not permitted to take photographs in the studio when there is a model present and it is good etiquette not to ask the model if they can be photographed.
